



**RULES / CRITERIA FOR APPOINTMENT OF GEPCO COUNSELS
ON GEPCO PANEL OF ADVOCATES APPROVED BY BOD
GEPCO IN ITS 36TH MEETING HELD ON 13-05-2014 AT AGENDA
NO.3 CIRCULATED VIDE COMPANY SECRETARY MEMO NO.
75569 DATED 23-05-2014.**

1. Standing practice on the credit of an advocate after enrolment as an Advocate with Punjab Bar Council shall be as under:
 - a. Seven years standing practice for Advocates of High Courts.
 - b. Five years standing practice for Advocates of Civil / District Courts etc.
2. Enjoying very good reputation amongst Bar Members and Public at large.
3. The integrity of an Advocate must be above the board beyond any shadow of doubt.
4. An Advocate must be known as an expert in the relevant field of Law. He should enjoy the reputation of being honest and Professionally Competent Advocate.
5. There should be no proceedings of any sort of misconduct of any Bar Council against the Advocate.
6. After enrolment on GEPCO Panel of Advocates he shall refuse the briefs against GEPCO.
7. An Advocate shall not be on the Panel of other Departments more three Departments.
