- i. The EOI Procedure will be based on two stage bidding mode as per PPRA rule 36(c).
- ii. The firm/bidder will be selected under quality and cost based selection (QCBS) method in accordance with the PPRA Rules 2004 and as per procedure described in the RFP.
- iii. It is mandatory for proposals to be prepared using standard forms of RFP. Any proposal not prepared according to prescribed format will be rejected. If information required by GEPCO in the forms is missing or written elsewhere, no credit will be given in the relevant section during evaluation
- iv. Conditional tender/bid will not be accepted.
- v. The prices should be firm and final without involving any foreign exchange.
- vi. Copy of registration with sales tax department: (if applicable) should be produced at the time of issuance of tender documents along with the bid schedule
